Overview

As stated in previous HMIS Newsletters ([Click Here](#) to view past newsletters), the MD BoS HMIS has undergone extensive review and many areas were identified to be corrected and improved. Updates made are in an effort to:

- 1) Bring MD BoS HMIS into compliance with HMIS Data Standards
- 2) Increase HMIS data quality
- 3) Collect data for agency & CoC report(s)

All of us working the homeless field understand it is the **person** experiencing homelessness, not the data, that is the primary focus of the CoC's homeless response system; *however, data is a vitally important tool* to be used by projects, agencies, and the CoC as a whole to show the picture of homelessness, and responses to it, in a community, agency, and project.

While HMIS data entry is not necessarily complicated, *it is precise*. To ensure that **all data entered** into MD BoS HMIS data creates an accurate picture of how individuals move through the homeless system and visualize system performance, both at the project & system level, it is **imperative** that the **correct data entry workflows** are being used.

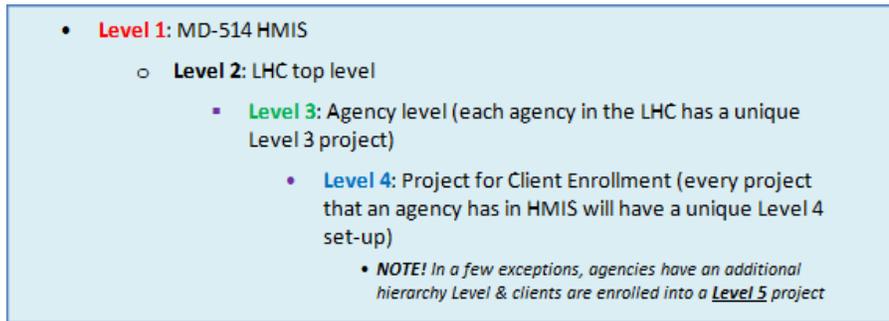

MD BoS HMIS Project Hierarchy & Naming Convention

The MD BoS HMIS project hierarchy follows the below format:



MD BoS HMIS utilizes the following standard **Naming Convention** for projects in HMIS:

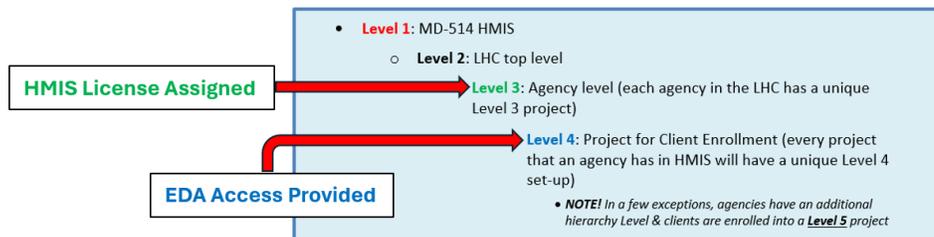
- **LHC initials_Agency initials: Project Name (Project Type – Fund Source)**
 - For example, a Rapid Re-Housing project called 'Coming Home', in the Garrett Co. LHC, receiving ESG funds would be: *GC_DSS: Coming Home (RRH – ESG)*

This will allow for quick identification of:

- LHC project is located in
- Agency the project belongs to
- Project Level
- Project Type (Emergency Shelter, Rapid Re-Housing, Permanent Supportive Housing, Street Outreach, etc.)
- Fund Source (CoC, ESG, HSP, etc.)

HMIS End User License Assignments

The MD BoS HMIS project hierarchy & EU license assignment follows the below format:



Where license are assigned is part of ensuring that the correct HMIS data entry workflows are being used.

- Correct workflows ensure the overall quality of data being entered into MD BoS HMIS

- Which is vital if the CoC is to have accurate reports to reflect system performance, both at the project & system level

HMIS End User (EU) licenses are assigned to Partner Agency **Level 3** project in HMIS; and **Enter Data As (EDA)** is then provided to the EU for each of the agencies **Level 4** HMIS projects that the EU will be entering client data into.

✚ As stated in the HMIS Policies and Procedures Manual, **“Executive Leadership at each Partner Agency must select at least one person to act as the designated Partner Agency HMIS Point-of-Contact (PoC).”** Multiple contacts may be appropriate for large agencies that operate multiple project types.

If your agency does not have a designated PoC, or needs to change it, please contact the HMIS Team via the Help Desk.

New HMIS End User (EU) Access & Training

The MD BoS CoC currently provides 1 of 2 types of HMIS End User (EU) licenses to MD BoS CoC member agencies **at no cost** to the agency:

- **DATA ENTRY License:**
 - Must access to *actively use* the system at least *once every 30-days* in order to maintain the license
- **READ ONLY License:**
 - Must access to *actively use* the system at least *once every 90-days* in order to maintain the license

To ensure that HMIS licenses are assigned **only** to individuals whose job duties **require** HMIS access, please follow the below steps:

1. The designated **HMIS Partner Agency Point-of-Contact (PoC)** will first submit a [New HMIS End User Request Form](#) using this [this link](#)
2. Once the MD BoS HMIS Team receives the completed [New HMIS End User Request Form](#), they will provide the new EU with access to the TalentLMS courses needed for their HMIS training
3. [New HMIS End User Training](#) is completed via **TalentLMS**. The online training course(s) allows the new EU trainee to complete the required training at a time that works best with their schedule.

The **New HMIS EU trainee is responsible** for:

- Following the instructions provided by the MD BoS HMIS Team, to complete the TalentLMS - HMIS New End User Training course(s)
- After completing the course(s) in TalentLMS, the trainee will receive instructions from the HMIS Team on how to:
 - Demonstrate their knowledge/understanding of HMIS data entry by creating 4 test client records in the HMIS Training site
 - Submit test client information to the MD BoS HMIS Team for review

Inactive HMIS End Users

To ensure that each license purchased by the CoC is being maximized to the fullest, the MD BoS HMIS policy requires all HMIS End Users to **actively use** the system in order to maintain the license.

The MD BoS CoC currently provides 1 of 2 types of HMIS End User (EU) licenses to member agencies **at no cost** to the agency:

- **DATA ENTRY License:**

- Must access to *actively use* the system at least *once every 30-days* in order to maintain the license
- **READ ONLY License:**
 - Must access to *actively use* the system at least *once every 90-days* in order to maintain the license

End Users that have not logged in & actively used their account within the above timeframes will be notified by the HMIS Team that:

- Their MD BoS HMIS license has been **deactivated**; and
- They have until the end of that month to **request reactivation**
 - Once reactivated, the EU must then immediately log in & actively use their HMIS account
 - EUs that have not used their HMIS account within **10-business days** of reactivation will have their HMIS license removed from the system

End Users removed from HMIS for any reason, are **required** to complete **New HMIS End User Training** prior to re-gaining access to the MD BoS HMIS.

HMIS Assessments

End Users must use '**Enter Data As**' to select the correct **Level 4** project they will be entering client data into

HMIS data is location sensitive, and client data is **ONLY** to be entered into the HMIS **Level 4** project that a client is enrolled in. To ensure that correct data entry workflows are being used, if the EU does not select an **Enter Data As** (EDA) project prior to entering client data – they will not be able to enter any client data & will see the below instructions on the assessment screen:

- **Prompts** when closing an assessment that has missing data
- **Section Headers & Guidance**, including:
 - **Who** data collection is required for in the household
 - **What** data collection is required by only specific Project Types
